Spotlight

On September 20, the National Agency Investigation released details of 43 mostwanted criminals. many associated whom are with gangster-terrorist networks having linked to Canada and Khalistan movement. Interestingly, the NIA list also included the name and details of Sukhdool Singh Gill aka Sukha Duneke, who was killed in a gangland hit in Canada on September 21. According to NIA sources, the gangster-terrorist (Khalistani) nexus, which shares similarities with the 'Mumbai underworld', was causing significant security concerns in Punjab. Due to the increasing number of gangsters hitmen fleeing to Canada, which has already become a safe haven for Khalistani terrorists, that country has effectively become part of an extended zone', previously Haryana, limited to Punjab, Rajasthan, and the National Capital Region in India.

The month in review

Indo-Canada diplomatic relations hit rock bottom in September, after Canadian Prime Minister Justin Trudeau made allegations about India's 'potential involvement' in the killing, on Canadian soil, of Khalistani terrorist Hardeep Singh Nijjar. This development elevated the entire Khalistan discourse to a different level, well beyond its previous status as a predominantly 'online' phenomenon.

On September 18, during an emergency session of the House of Commons (Canada's Lower House of Parliament), Canadian Prime Minister Justin Trudeau asserted, "Canadian security agencies have been actively pursuing credible allegations of a potential link between agents of the government of India and the killing of a Canadian citizen, Hardeep Singh Nijjar... The involvement of any foreign government in the murder of a Canadian citizen on Canadian soil is an unacceptable violation of our sovereignty." Subsequently, Canadian Foreign Minister Mélanie Joly announced the expulsion of a senior Indian diplomat, Pavan Kumar Rai, the head of Research and Analysis Wing (RAW) in Ottawa.

In a tit-for-tat move, India expelled the senior Canadian diplomat and the Canadian intelligence agency chief based in India on September 19, and strongly rejected Trudeau's allegations as 'absurd' and 'motivated,' while emphasizing its commitment to the rule of law.









India also urged Canada to take legal action against anti-India elements operating on its soil. These developments were accompanied by escalating diplomatic tensions, including the cancellation of visa issuance, as well as adverse travel advisories by both countries.

Amidst rising Indo-Canadian bilateral strains, a Punjabi gangster associated with Khalistani elements in Canada and wanted by the National Investigation Agency (NIA), Sukhdool Singh Gill *aka* Sukha Duneke, was killed on September 21 in what is believed to be an incident of inter-gang rivalry at Winnipeg in Canada's Manitoba province. Shortly after the incident, the Punjab-based Lawrence Bishnoi and Canada-based Goldy Brar's gang claimed responsibility for the killing in a social media post, declaring that it was in retaliation against Duneke's alleged involvement in three murders in Punjab. Duneke, had 18 criminal cases against him, including charges related to murder and extortion in India, and fled to Canada in 2017 counterfeit documents. From Canada, he was running gang activities, including an extortion racket and targeted killings, in Punjab.

Though parts of Trudeau's 'credible allegations' were purportedly based on 'intelligence' collected by a member of the Five Eyes alliance – United States, United Kingdom, Australia, New Zealand, and Canada – it was reported that the alliance declined Canada's request to collectively condemn the killing. Nevertheless, most Western countries, including the US, took the 'allegations' seriously, requesting India to cooperate with the ongoing investigation and wait for the conclusion.

India, on the other hand, chose to highlight the threat posed by Khalistan separatism and its larger networks among global organized crime syndicates. India also emphasized Canada's persistent negligence in addressing this issue, pointing out how the Trudeau government had chosen to repeatedly ignore hard evidence shared by Indian agencies, lists of 'most-wanted' gangsters and terrorists, and extradition requests, in the past. India criticized Trudeau for what it saw as playing 'vote bank' politics to secure the support of the 'pro-Khalistani Sikh caucus' in domestic politics.

India's neighbours, Sri Lanka and Bangladesh, openly supported India and criticized Canada for providing safe haven to criminals from South Asia, citing examples of Liberation Tigers of Tamil Eelam (LTTE) and Islamist terrorists who had obtained Canadian citizenship and were currently residing there due to a prejudiced asylum process.

Indian security agencies initiated action against Khalistani elements based in the West, especially in Canada. The National Investigation Agency (NIA) confiscated land and a portion of a house belonging to the 'chief' of Sikhs For Justice (SFJ), Gurpatwant Singh Pannun, in Khanoti village in the Amritsar district of Punjab and Chandigarh, on September 23. The NIA is also in the process of impounding properties belonging to other Khalistani terrorists and gangsters, including Hardeep Singh Nijjar, in Punjab.

SFJ's proposed Khalistan referendum event on September 10 at Tamanwis Secondary School in Surrey, British Columbia, Canada, was officially cancelled, as the school authorities revoked permission due to concerns raised by various societies regarding the event, as well as the use of promotional materials featuring weapons such as AK-47s. Nevertheless, the event was organised at the Guru Nanak Sikh Gurdwara in Surrey, British Columbia, but recorded a very low turnout, prompting the event organizers to schedule a 'revote' on October 29.

Meanwhile, the Punjab police and central security agencies effectively neutralized various terrorist-gangster-drug smuggling networks operating within Punjab. Data collated by the *Khalistan Extremism Monitor* (KEM) indicates that at least 20 individuals were arrested due to their alleged ties to Khalistan terrorist activities or organized gang networks, and an additional 122 individuals were arrested in relation to drug seizures in the state during September 2023.

On September 4, Sukhchain Singh Gill, Inspector General of Police (IGP) Headquarters, announced that the Punjab Police had arrested 19,093 drug smugglers, including 2,778 major culprits, and registered a total of 14,179 FIRs, with 1,717 related to commercial drug quantities in the preceding 14 months. A total of 1,548.27 kilograms of heroin, 871.82



kilograms of opium, 446.30 quintals of poppy husk, 905.9 million tablets/capsules/injections/vials of pharmaceutical opioids, were seized across the state during this same period, and INR 139.6 million in drug money was recovered.

Khalistan referendum event in Surrey school cancelled amidst community concerns

The proposed Khalistan referendum event scheduled for September 10 at Tamanwis Secondary School in Surrey, British Columbia, Canada, was officially cancelled. The school's board of trustees revoked permission due to concerns raised by various societies and the use of promotional materials featuring weapons such as AK-47s. The cancellation followed opposition from the local community, concerned about the event's association with the Khalistani outfit Sikhs For Justice (SFJ), which is proscribed in India, and its glorification of terrorists and weapons. This led to calls for a halt to the event's use of public-school premises.

Canadian Sikhs' thumbs down to 'Khalistan referendum'

The Sikhs For Justice (SFJ) 'Khalistan referendum', held on September 10 at the Guru Nanak Sikh Gurdwara in Surrey, British Columbia, Canada, witnessed a low turnout, prompting the event organizer to schedule a re-vote on October 29. SFJ chief Gurpatwant Singh Pannun delivered a speech in which he claimed widespread participation, but local Sikhs largely dismissed the referendum as a 'sham exercise' that didn't represent their sentiments. They cited its association with controversial figures, such as Talwinder Singh Parmar and Hardeep Singh Nijjar.

Lahore Police's anti-narcotics chief heads gang smuggling drugs into India

Pakistan's Anti-Narcotics Force (ANF) has exposed a significant drug-smuggling network operating in India, led by Mazhar Iqbal, the head of the Lahore Police's anti-narcotics wing. Iqbal and his network used drones to smuggle drugs, particularly heroin, from Kasur in the Punjab Province of Pakistan, into Indian Punjab. Despite a history of dismissals and suspensions related to illegal activities, Iqbal held a key position in the anti-narcotics department of Lahore Police. The police investigation revealed that a drone in Mazhar Iqbal's network, transported up to 6 kilograms of drugs across the border into Indian Punjab. The network was exposed after the arrest in Pakistani territory, of six Indians from Punjab.

NIA special court forfeits properties of listed Khalistani terrorist Rinda's aides

The National Investigation Agency (NIA) announced, through a press release on September 14, that it had secured a landmark court order from a special NIA court in Haryana for the forfeiture of the properties of terrorists, including cash and an SUV, belonging to four associates of Pakistan-based Babbar Khalsa International (BKI) terrorist Harwinder Singh Sandhu alias Rinda. This action, taken under Section 26 of the Unlawful Activities (Prevention) Act (UAPA), marks a significant step in the NIA's strategy to disrupt the financial resources of terrorist organizations.

Jailed Khalistan poster boy Amritpal now totally out of the picture in his own village

According to reports, the radicalization efforts of Amritpal Singh, the jailed Khalistani supporter from Jallupur Khera village in Amritsar district, have been dismantled. The residents of his village now claim that the movement for Khalistan was a false narrative created by Amritpal Singh, and there is no such sentiment on the ground. They attribute the issue of drug abuse as a more significant concern and emphasize the need for job opportunities, to prevent youth from turning to drugs or Khalistani ideologies. Amritpal Singh's influence in the village appears to have waned, and he is expected to remain in jail for a long time due to the serious charges against him.

Trudeau says Canada has evidence linking India to Khalistan leader's killing

During an emergency session of the House of Commons (Canada's Lower House of Parliament) on September 18, Canadian Prime Minister Justin Trudeau escalated a diplomatic standoff with India by claiming that his government was investigating "credible allegations" of India's involvement in the killing, on Canadian soil, of a prominent Khalistani terrorist and the deceased chief of the Khalistan Tiger Force (KTF), Hardeep Singh Nijjar. Prime Minister Trudeau stated that Canadian national security authorities had reason to suspect that "agents of the Indian government" were responsible for Nijjar's murder. Nijjar served as the president of Surrey's Guru Nanak Sikh Gurdwara.

Khalistani terrorist Gurpatwant Singh Pannun threatens Hindus in Canada

Gurpatwant Singh Pannun, the chief of the banned Sikhs For Justice (SFJ), issued a threat to Hindus living in Canada in a viral video. NIA intensifies crackdown on pro-Khalistan terrorists operating in India

On September 20, the National Investigation Agency (NIA) announced a reward of INR one million, for information leading to the arrest of the listed Khalistani terrorists Lakhbir Singh Sandhu *alias* Landa, and Harwinder Singh Sandhu *alias* Rinda. Additionally, a reward of INR 500,000 was announced for information leading to the arrest of three associates of these terrorists, Parminder Singh Kaira *alias* Pattu, Satnam Singh *alias* Satbir Singh *alias* Satta, and Yadvinder Singh *alias* Yadda.

Khalistan-linked gangster Sukha Duneke killed in intergang rivalry in Canada

Gangster Sukhdool Singh *alias* Sukha Duneke, who was wanted by the National Investigation Agency (NIA) for a series of targeted killings and suspected links with pro-Khalistan terrorists, was killed on September 21 in inter-gang rivalry at Winnipeg, in Canada's Manitoba province. He had escaped to Canada in 2017 using forged documents and had a long criminal record, with at least 18 cases, including murder and extortion. Duneke was actively involved in managing his gang's activities from abroad, running an extortion racket, and orchestrating targeted killings, including those of rival gang members in Punjab. His name was on the NIA's wanted list, and he had connections to other criminal figures in Canada as well as other countries.

NIA confiscates properties of Sikhs For Justice chief Gurpatwant Singh Pannun

On September 23, the National Investigation Agency (NIA) confiscated land and a portion of a house belonging to Khalistani terrorist Gurpatwant Singh Pannun, the chief of the banned Khalistani outfit Sikhs For Justice (SFJ), at Khanoti village in the Amritsar district of Punjab, and in Chandigarh. The properties confiscated included 46-kanals (5.7 acres) of agricultural land at Khankot village and a one-fourth share of a house in the Sector 15/C area of Chandigarh.
